SUPERIOR COURT CIVIL ACTION FILING FEE & PARTNERSHIPS - **\$207.50**

*** State, Municipalities, counties, political subdivisions or agencies are exempt from \$15 POPIDF-B and \$125.00 Judicial Operations Fund fees.*

MAGISTRATE COURT CIVIL ACTION FILING FEE - **\$52.50**

AFFIDAVIT OF ABANDONED MOTOR VEHICLE - **\$159.50 SUPERIOR/\$42.50 MAGISTRATE**
(plus **\$3.00** Motor Vehicle Judgment Certification)

SHERIFF SERVICE - **\$50.00** per defendant for civil action and garnishments
Plus **\$6.00** for service of additional garnishee on same action

\$25.00 for service process of Dispossessory per defendant & service of Eviction Order

\$10.00 for service of Witness Subpoena

\$50.00 for levy or Writ of Fieri Facias

\$20.00 for search and Return of Nulla Bona

SHERIFF SERVICE OUTSIDE DADE COUNTY – Please present separate check for the service fee **PAYABLE** to the Sheriff/Marshall performing the service and provide a postage paid envelope addressed to that Sheriff/Marshall.

CIVIL PUBLICATION FEE - **\$80.00**-ADOPTION PUBLICATION FEE - **\$60.00** (Payable to legal organ)

SUBPOENA - **\$5.00** EACH

APPEALS AND TRANSFERS (cost of preparation), plus appropriate cost of transferee court

- Preparation of record, per page **\$10.00**
- Transcript, each **\$35.00**
- Each Clerk's Certificate **\$1.00**
- Each Court Seal **\$1.00**

REAL ESTATE RECORDINGS - **\$10.00** plus **\$2.00** each additional page plus **\$2.00** per applicable cross reference

***Self-addressed stamped envelope **must be** provided with all real estate filings.*

TRANSFER & ASSIGNMENTS of Security Deed - **\$5.00** per assignment plus **\$2.00** per cross reference

PLAT - **\$8.00** per page

LIEN/FIFA RECORDING FEE - **\$5.00** plus **\$2.00** each additional page (Nulla Bona is generally \$9.00)

**** Plus \$4.00 additional issuance fee applies to Magistrate Court Fifa's.**

LIEN/FIFA CANCELLATION FEE - **\$5.00** plus **\$2.00** per cross reference fee per instrument being cancelled

UCC FILING (Financing Statement) - **\$10.00** plus **\$2.00** each additional page

Please note that any UCC that is to be recorded in the real estate records must use the required addendum form with block 6 marked, contain the legal description, and property owners name.

TRADE NAME - **\$157.00** (plus \$40.00 Publication fee payable to legal organ)

NOTARY PUBLIC APPLICATION - **\$37.00**

COPIES

- Unassisted copy, per page \$0.50
- Unassisted copy, per page (larger than 8.5 x 14) \$2.00
- Assisted copy, per page \$1.00
- Certified or exemplified copy \$2.50 first page, \$0.50 each additional page
- Fax or electronic copy \$2.50 first page, \$1.00 each additional page
- Computer generated printout or data \$2.50 per page

GENERAL INFORMATION:

Overpayments of recording/filing fees will not be refunded unless it is **\$15.01 or more.**

Self-addressed postage paid envelope **must be** provided with all real estate filings.

Case initiation and disposition forms are required for superior court civil filings.

All documents sent for filing **must have original signatures.**

If you request a “stamped filed” copy to be returned to your office, the copy and a self-addressed postage paid envelope **must be** provided.

Copy Request – Must submit appropriate fee & written request with identifying information, such as Case Number, Deed Book & Page Name, etc and must specify exact documents needed.
